### **JOB DESCRIPTION**

Under the direction of the Regulatory Compliance Manager, the Import and Export Trade Compliance Analyst provides import, export and logistics compliance guidance to Company employees supporting its operations and programs at various HQs. The position will support the Regulatory Compliance Manager with corporate global trade controls compliance, including, but not limited to: importing, exporting, customs clearance, freight forwarding, logistics, compliance policy and procedure development, implementation, training and daily operations.

Must be, and remain, current with US Government (USG) regulations under the Export Administration Regulations (EAR), Customs and Border Protection (CBP), FDA Centers for Diseases and Radiological Health (CDRH), National Highway Traffic Safety Administration (NHTSA), Foreign Trade Regulations (FTR), Office of Foreign Assets Control (OFAC), and associated foreign government agencies.

Must have direct experience and expertise in importing, exporting, HTS and ECCN classifications, CCATs, logistics, filing associated documents, and working with customs brokers and freight forwarders. Knowledge of EU Import Regulation, including standards for product safety, labelling, custom duties, and import restrictions, would be an advantage.

- Prepare and process licenses, agreements, exemptions, and associated documentation
- Ensure all international trade compliance records are maintained as required
- Assist in the conduct of compliance audits

- Assist in the preparation of export compliance training
- Perform all Denied Party Screenings, supplier verifications check and maintain records
- Assist in the creation of, and maintain an organisational database for accurate item classification under EAR, ECCN, FDA, CBP HTS, Schedule B
- Assist in the creation of a tracking, storage, and retrieval system for documentation
- Prepare other import/export documentation as required
- Utilise agency-identified programs such as SNAP-R, ACE (AES) e-Submitter/ESG, D-Trade
- Maintain all compliance records, databases, recordkeeping

- Ensures compliance with administrative requirements applicable to export and import transactions, including customs and FDA clearances, EU clearances, carnets, and all logistics activities
- Perform other duties as assigned
