This involves overseeing and managing the overall design, building, and testing of IT services and solutions – on time, within budget, meeting customer and business requirements and in compliance with all relevant standards. It also includes the controlled decommissioning of obsolete services and solutions with minimal disruption.

Global Head of IT will define the IT organisation's overall approach to the delivery of IT services, in line with business objectives and constraints. This includes defining and managing the processes, standards, tools and other enabling technology used within the service delivery framework.

- Create and maintain IT service delivery model
- Collaborate with the CITO to define IT service delivery locations, respective activities and sourcing strategy for service delivery skills
- Establish and manage the service delivery processes and standards
- Identify, deploy and support service delivery tools and enabling technology
- Lead the execution of project deployment plan in line with the agreed solution
- Manage implementation of testing standards across all projects
- Oversee the transition of solutions to the BAU operations
- Collaborate with the Global IT Infrastructure Architecture team to co-ordinate all solution design matters
- Prepare and arrange reports, budgets and forecasts and presenting them to governing bodies
- Meet regularly with direct reports to review performance, recommendations and reports, and identify any issues and set expectations of goals

- Represent the organisation at official occasions, in negotiations, at conventions, seminars, public hearings and forums, and liaising between areas of responsibility
- Ensure adoption and implementation of the Ainira project management methodology across all of Company's IT infrastructure and application projects
- Manage the delivery of project and program management services (analysis, development, configuration, testing, transition, change management) across all of Company's infrastructure and application projects
- Collaborate with the global IT Leadership Team to develop and manage project and program budgeting and cost estimation, resource allocation, and re-allocations
- Plan and coordinate user acceptance testing, and obtain necessary resources
- Develop project and program resourcing strategies to ensure optimum support for projects and for the day-to-day operational activities
- Provide periodic reporting to CITO and other key stakeholders
